

I, JENNA KRAUSHAAR, of the City of Regina, in the Province of Saskatchewan, Professional Responsibility Counsel for the Law Society of Saskatchewan, do hereby certify that Leslie Belloc-Pinder, Q.C., Chair of the Discipline Committee of the Benchers of the Law Society of Saskatchewan, has appointed a Hearing Committee pursuant to Section 47(1) of *The Legal Profession Act, 1990*, comprised of James Korpan, Q.C., as Chair, Lynda Kushnir Pekrul and Ronni Nordal to hear and determine a Formal Complaint set out by the Conduct Investigation Committee pursuant to Section 46(1) of *The Legal Profession Act, 1990*, against **Douglas Heinrichs, Q.C.**, a lawyer and a member of the Law Society of Saskatchewan, carrying on the practice of law at all of the relevant times in the City of Swift Current, in the Province of Saskatchewan, as follows:

THAT DOUGLAS HEINRICKS, Q.C., of the City of Swift Current, in the Province of Saskatchewan is guilty of conduct unbecoming a lawyer in that he:

- 1. did accept cash in an aggregate amount of \$13,000.00 in respect of one transaction, contrary to Law Society of Saskatchewan Rule 909.
